#### C. Reason

#### (1) Condition

Instances have occured where the retainer of the stage 10 case seal ring assembly have been deflected forward following release of a number of its securing rivets.

#### (2) Background

A review of fitting procedures has established that the rear outer casing can foul the seal assembly if it is not properly aligned during engine assembly and this may cause overstressing of the rivets. Service Bulletin V2500-ENG-72-0154 was subsequently introduced to reduce rivet stresses by increasing the number of securing rivets.

#### (3) Objective

To prevent stressing of the rivets at engine build.

#### (3) Substantiation

The mechanical integrity of the modified design has been proven by stress analysis.

#### D. <u>Description</u>

This Service Bulletin instructs a new HP compressor stage 10 case assembly with the integral seal retaining arm extended forwards to support the front face of the seal ring.

The retainer is transferred to the outside of the stage 10 case to support the rear face of the seal ring.

At engine build the integral seal retaining arm supports the ring seal thus lowering build stress levels, enabling a reduction in the number of rivets on the retainer from 96 to 24.

The part number changes and/or part modifications described in Section 2 and 3 of this Service Bulletin have been shown to comply with the applicable Federal Aviation Regulations and are FAA-APPROVED for the Engine Model listed.







## VIEW ON STAGE IO CASE ASSEMBLY BEFORE ALTERATION

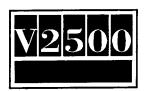


# VIEW ON STAGE IO CASE ASSEMBLY AFTER ALTERATION
